One story I will never forget was that she would invite each grandchild every year to Florida. One of the grandsons told of how there were only two rules for that week with their grandparents, and each day both of the rules had to be followed before

the grandchild went outside to enjoy the sun. Number one - they had to lather up with sunscreen, and number two - they had to memorize the Bible verse Marilyn posted on the refrigerator each morning. Amidst the laughter, there was a confirmation from each grandchild that Marilyn had made an indelible imprint on their lives.

As I sat there with tears in my eyes, I heard the pastor say that he had rarely heard testimonials from grandchildren so rich in a spiritual legacy. My own memories of Marilyn flooded back, as I, too, was the beneficiary of her generous spirit, as every event in my life, sad or happy, was greeted with a card of encouragement or congratulations.

Oh, what a legacy she left. While I am sure her legal affairs were in order, that was not mentioned at this most honoring of services. We should all get our estate in order for, as Marilyn would always say, "You never know what is around the corner." Then, our minds and our hearts will be free to engage in what is truly important to leave behind. What will your grandchildren (or your best friend's children) say about you?
